THE PROTECTION OF PERSONAL INFORMATION ACT: CUSTOMER PRIVACY NOTICE

This Notice explains how we obtain, use and disclose your personal information, in accordance with the requirements of the Protection of Personal Information Act ("POPIA"). At ELI, we are committed to protecting your privacy and to ensure that your personal information is collected and used properly, lawfully and transparently.

We confirm that all business, personal and related information shared with us for all possible reasons is secured and is and will not be shared with others unless specifically requested or authorised by yourself.

The information we collect

We collect information directly from you where you provide us with your personal details. We collect and process your personal information in order to efficiently deliver our services to, or engage with you, amongst others, as a learner, beneficiary, sponsor, service provider, moderator, assessor, contractor or associate. We will inform you about the minimum information you are required to provide to us, depending on your role or interaction with us. We will also advise you if it will be necessary for us to share your information with a third party (such as a service provider).

How we use your information

We will use your personal information only for the purposes for which it was collected and agreed with you. For example:

- To gather contact information
- To confirm and verify your identity in order to enrol you as a beneficiary of one of our programmes
- To confirm and verify your identity and other key factors when appointing, amongst others, project managers, contractors and service providers
- For student and qualification record keeping purposes
- Reporting to sponsors
- Making payments to you

Disclosure of information

We may disclose your personal information to our service providers who are involved in the delivery of services to you. When we contract with third parties, we impose appropriate security, privacy and confidentiality obligations on them to ensure that personal information that we remain responsible for, is kept secure.

We may also disclose your information where we have a duty or a right to disclose in terms of law or industry codes.
